FEE SCHEDULE

(Revised September, 2010)

Standard Services:

Neuropsychological Evaluations/Adult	(Ages 16 and up)	\$ 6000
Neuropsychological Evaluations/Child	(Ages below 16)	6000
Psychodiagnostic Evaluations		5000

*Note: All services must be **paid 72 hours in advance**, in full, unless other arrangements have been made.*

There will be additional charges if further sessions are required in order to complete our assessments, generally at the rate of \$1,500 per additional session.

*For all forensic cases, a **\$6000 retainer fee must be received 72 hours in advance** of the scheduled appointment (\$5,000 for psychodiagnostic evaluations), or the appointment will be cancelled.*

Additional Forensic Services:

Hourly Consultation Rate (e.g., telephone, in-person, etc.)	500/Hour
<i>(Telephone consultations will be billed in quarter-hour increments)</i>	
Review of Medical and Other Records	500/Hour
Preparation for Deposition or Trial	500/Hour
Deposition Testimony conducted on-site at Neuroscience Associates Inc. (2 hour minimum)	750/Hour
Deposition Testimony conducted off-site will take place by special arrangement only	
<i>(Half-day or full-day courtroom testimony rates will apply)</i>	
Trial/Arbitration Testimony, full-day , paid in advance 7 days prior	7500
Trial/Arbitration Testimony, half-day (starts at 1pm), paid in advance 7 days prior	4500
<i>(The issue of full-day versus half-day must be decided one week prior to scheduled testimony date due to scheduling demands)</i>	
Travel Time	500/Hour

** For all services conducted off-site and requiring air transportation and/or an overnight stay (including patient examinations, deposition or trial testimony), the charge will be \$7500 per day (no half-day rates), to be paid 72 hours in advance of departure; additional charges for travel and accommodations will apply.*

Cancellation Policy: Must provide at least 72 hours notice for full-fee return, and minimum 48 hours notice for half-fee return. Day of service cancellation or “no show” pays full-fee without exception, and no fees will be returned.

Parking: Full-day parking in the Cedars-Sinai Medical Towers is \$13.65 per day (which accrues in full after only two hours). Unfortunately, we do not validate. However, less expensive parking is available at several lots within 2-3 blocks of our building at approximately half this rate (\$6/day).

Invoices are due and payable within 30 days of receipt. Balances not paid in full within 60 days are subject to an interest charge of 5% per month to offset additional administrative and collection expenses.
